As you are aware, the County Official Plan Amendment application 42-04-36-OPA-123 and Township Zoning By-law Amendment application have been appealed to the Ontario Municipal Board (OMB).

Please note that the County Official Plan Amendment application has been placed on the December 14<sup>th</sup>, 2017 Grey County Committee of the Whole agenda. The Township Zoning By-law Amendment application has been placed on Chatsworth Council agenda for December 20<sup>th</sup>, 2017. A copy of the County staff report has been enclosed with this letter. A copy of the Township staff report will be made available on December 15, 2017 as part of the December 20<sup>th</sup> Council agenda.

Please be aware that neither Grey County Council, nor Chatsworth Council, are the approval authority for the Official Plan or Zoning Amendments any longer. Based on the appeals, the approval authority is now the Ontario Municipal Board. The aforementioned staff reports will be making recommendations to establish County and Township positions with respect to the applications and the Board process.
