

CORPORATION OF THE TOWNSHIP OF CHATSWORTH

BY-LAW NO. 2008-29

BEING A BY-LAW UNDER THE PROVISIONS OF SECTION 150(1) OF THE MUNICIPAL ACT, S.O. 2001 AS AMENDED FOR THE LICENSING, PROHIBITION AND REGULATION AND OF CHIP WAGONS AND PORTABLE FOOD SERVICE CARTS.

Whereas PART IV of the Municipal Act, S.O. 2001, as amended, authorizes councils of local municipalities to pass by-laws for the licensing, regulation and governing of any business carried on within the municipality;

And whereas council deems it expedient to pass a bylaw to license, regulate and govern chip wagons and portable food service carts within the municipality in order to provide for the health and safety and consumer protection of the public;


Now therefore the council of the Corporation of the Township of Chatsworth enacts as follows;

1. This by-law shall be administered by the Clerk of the Township of Chatsworth
2. No Chip Wagon or Portable Food Service Cart shall be operated unless it is licensed under this by-law and licensing shall be required annually.
3. This by-law shall be read and interpreted in conjunction with the current zoning by-law of the Township
4. An application attached as Schedule A shall be submitted to the Clerk for review and shall include a site plan showing the proposed location of the Chip Wagon or Portable Food Service Cart, the proposed parking area for a minimum of 2 off street parking spaces and, if applicable, the proposed seating area, washrooms, litter containers, etc.

5. A non refundable application fee of \$100 shall accompany the application. Any further fees shall be set out in the Township fees and charges by-law as amended from time to time.
6. Proof of a food service premise approval from the Grey Bruce Health Unit shall be provided to the Township.
7. Proof of a legal entrance shall be provided to the Township
8. Proof of Liability insurance shall be provided to the Township.

This by-law shall come into force and effect upon the passing thereof.
