If legal non-conforming status is claimed, a statutory declaration will be required in accordance with the attached Schedule “A” to the effect that the use of the property as a wrecking yard, salvage shop, and/or salvage yard has been continuous since the adoption of the Zoning By-law.</p> <p><b>Site Regulations</b> – All site regulations as set out in the Wrecking Yard, Salvage Shop, and Salvage Yard By-law, must be adhered to including the presence of a planting strip and/or a closed wooden, plastic or metal fence extending at least 1.8 metres in height from the ground.</p> <p><b>At any time the Township of Chatsworth By-law Enforcement Officer or his/her designate may enter and inspect the property and no person shall obstruct nor hinder such inspection.</b></p>
