

# Declaration of Pecuniary Interest Registry

## Municipal Conflict of Interest Act Requirements

Under the Municipal Conflict of Interest Act, The Township of Chatsworth is required to establish a public registry wherein written statements of pecuniary interest by Members of Council are maintained for public record.

Section 6.1 of the Act requires municipalities and local boards to establish and maintain registries that keep copies of statements filed under Section 5.1 and of declarations recorded under Section 6 of the Act.

The registry, which includes the written statements of pecuniary interest, is available on the Township website. For additional information, please contact the Clerks Department.
